- 4,580 PPO providers in the Chicago MSA out of 9,053 total = 50.6% of available providers in network (increase of 312 providers from last year)
- 347 DHMO dental offices in the Chicago MSA while the next closest competitor has 264. The network has been stable with 346 DHMO dental offices in the Chicago MSA last year






